Clerk's Report – 14 May 2020 Remote Meeting

Agenda Item 6 (a) – Playground Inspection Reports – Weekly inspection reports since February 2020 meeting to be presented at the meeting and any matters arising to be discussed.

Agenda Item 6 (b) – Business during Coronavirus – A schedule of essential business, transacted since the February 2020 meeting with approval by the Chairman and Vice-Chairman in conjunction with the Clerk, will be presented for ratification approval. The schedule will be circulated in advance of the meeting. This business was carried out during a period when physical meetings were prohibited as a result of the lockdown imposed by the coronavirus outbreak and before legislation for remote meetings was in place. This was further to email or oral confirmation from all members delegating this authority to keep all normal operations running to ensure the delivery of council services further to an email from the Clerk dated 23 March 2020 after the Extraordinary Meeting scheduled for Tuesday 24 March 2020 was forced to be cancelled. Note The Local Authorities and Police and Crime Panels (Coronavirus)(Flexibility of Local Authority and Police and Crime Panel Meetings)(England and Wales) Regulations 2020 (“the 2020 Regulations”) came into force on 04 April 2020.

Agenda Item 6 (c) – Parish Land Licences to Occupy – The current licences issued in respect of occupying parish land have expired or will do shortly and renewal of these licences needs to be considered. In addition a request to increase the plot of land licensed to the rear of 39 Lower Lane to be considered.

The following licences to be considered

- Parish Land to the rear 39 Lower Lane for one further year at a cost of £10
- Parish Land to the rear 33 Lower Lane for one further year at a cost of £10
- Parish Grazing Land off the B6062 adjacent to Buxworth Recreation Ground for one further year at a cost of £300

Agenda Item 6 (d) – 2020-21 Meeting Dates – the proposed list of meeting dates for the 2020-21 year will be circulated for approval. These meetings will be held remotely until such time when they may be resumed face-to-face in the Parish Room.

Agenda Item 6 (e) – Minor Maintenance Scheme – consider invitation to participate in the 2020/21 Public Rights of Way Minor Maintenance Scheme. The parish council has been allocated £565. To participate we need to confirm to DCC by 21 June 2019 by completing Form 1 MMA indicating planned works for the year.
