## **Clerk's Report – January 2020**

**Agenda Item 6 (a) – Chinley Community Centre Project** – An update will be given on the progress of the Project Group.

**Agenda Item 6 (b) – Playground Inspection Reports** – Weekly inspection reports to be presented at the meeting and any matters arising to be discussed.

**Agenda Item 6 (c) – Buxworth Allotments** – Further to the November meeting it has been established that a hawthorn hedge around each block of 6 allotment plots on the Buxworth allotment site did form part of the original plans as can be seen on planning application HPK/2011/0487. An update will be given at the meeting on the initial thoughts of Buxworth Allotments Association and consideration can be given on how next to proceed.

**Agenda Item 6 (d) – Christmas 2019** – Invoices will be presented for additional lights required for the small trees as well as for additional works required of the electrician. Any feedback on the Christmas lights and events would be welcome to feed into planning for 2020.

**Agenda Item 6 (e) – Rights of Way Minor Maintenance Agreement 2019/20** – a proposal to carry out surface maintenance works to CBB Footpath 20 in Buxworth Recreation Ground and a quote for these works will be presented for approval. The proposed works have been agreed as suitable under the scheme by one of DCC's Public Rights of Way Assistants.

**Agenda Item 6 (f) – Buxworth Path to Playground** – Cllr Drabble has collected some used Kee-Klamp handrails which are in excellent condition, donated to us for free by Peak School. They may be suitable for installing on the footpath down to Buxworth Playground. Consideration to be given on whether to get quotes for this or to consider a quote to install a wooden handrail.

**Agenda Item 6 (g) – Friends of Chinley Park Service Level Agreement** – FOCP have made some very minor amendments to the Service Level Agreement last signed between FOCP and the Parish Council in 2008. Further amendments have been proposed and circulated to the parish council representatives of FOCP. I will circulate a draft amended agreement in advance of the meeting for consideration.

**Agenda Item 6 (h) – Litter Picking Events** – to consider whether the parish council wishes to host litter picking events once again in conjunction with The Great British Spring Clean which runs from 20 March to 13 April 2020. Suggested weekend of 28/29 March 2020.

**Agenda Item 6 (i) – Garage on Chinley Playing Fields** – the Community Association have written to give an update on the garage on Chinley Playing Fields. Consideration to be given on next steps.

**Agenda Item 6 (j) – Grounds Maintenance** – quotes will be presented for additional Grounds Maintenance tasks recommended in Buxworth Recreation Ground for consideration.
