Clerk's Report – June 2019

Agenda Item 6 (a) – Chinley Community Centre Project – The planning application has been submitted and is awaiting validation. An update will be given at the meeting.

Agenda Item 6 (b) – Playground Inspection Reports – Weekly inspection reports to be presented at the meeting and any matters arising to be discussed. Quotes will be presented for some fencing/gate repairs at Buxworth Playground that have already been identified.

Agenda Item 6 (c) – Annual Playground Inspections – The annual RoSPA Play Safety Inspections have been received covering both Chinley and Buxworth playgrounds and Chinley Skatepark/Cycle Facility. A report summarising the recommendations will be circulated in advance of the meeting.

Agenda Item 6 (d) – Buxworth Car Park – Quotes have now been received to install a speed bump to divert rainwater away from the track down to the allotments as well as to lay road planings to improve and tidy up the existing track. These will be considered at the meeting.

Agenda Item 6 (e) – PDNPA Parish Statement – A draft parish statement written by Peak District National Park Authority for their website has been circulated to parish councillors, Chinley & Buxworth Community Association and Chinley & Buxworth Transport Group for comment. An update will be provided at the meeting where next steps can be considered.

Agenda Item 6 (f) – Seating/benches in the parish – Councillors Drabble and Smith are carrying out the annual audit of seating/benches in the parish. Recommendations will be presented at the meeting and quotes if time allows.

Agenda Item 6 (g) – VE Day 75 (8 May 2020) – A letter was sent out with DALC Circular 7 detailing plans for VE Day 75 on 8 May 2020 to celebrate and commemorate the 75th anniversary of VE Day. This day will coincide with the May Bank Holiday which has been moved from the Monday to the Friday for 2020. Consideration will be given to whether we organise any parish events in conjunction with this.

Agenda Item 6 (h) – Pest Control (Moles) – A quote has been received to carry out annual pest control of moles at Chinley Playing Fields and Buxworth Recreation Ground. Consideration will need to be given to whether we continue with this.

Agenda Item 6 (i) – Utility Aid – A quote will be provided for supply of electricity to the Parish Room with Utility Aid, the UK's largest broker for the not-for-profit sector.
