## **Items of Correspondence – 29 April 2021 Remote Meeting**

### **Received: 26 March 2021 – 23 April 2021**

- 1.) 20's Plenty for Derbyshire – a follow up letter from the campaign group requesting consideration be given to supporting a 20mph policy for Derbyshire.
- 2.) Chinley Allotments Association – request to cut down 3 trees that are shading a couple of allotment plots.
- 3.) DCC - temporary closure of Footpath 1 in Chinley, Buxworth & Brownside parish from 13 April 2021 to 5 May 2021.
- 4.) HPBC – details of an appeal against the Council's decision to refuse planning permission for the proposal detailed in planning application HPK/2020/0062 at Buxworth Football Club, Western Lane, Buxworth.
- 5.) HPBC – invitation to speak in support or against planning application HPK/2021/0006 at the Development Control Committee on 19 April 2021.
- 6.) Local resident – response regarding boundary fence at Chinley Playing Fields.
- 7.) DCC Cllr Simon Spencer – in response to the Parish Council's letter regarding the Peak Forest Tramway Reinstatement, he expressed support in principle for the proposals which remains the County Council's current position. However due to limited resources they have to concentrate on the priorities as detailed in the report approved by Cabinet on the Key Cycle Network back in January 2020 which form the basis for future cycle infrastructure development in the county. Progress is dependent on available resources and their main focus currently is on the completion of the White Peak Loop.
- 8.) Local resident – requesting the Parish Council's formal support for a local rewilding project along the Blackbrook Corridor and for the Parish Council to consider assigning land at Buxworth Recreation Ground to the project.
- 9.) Chinley & Buxworth Transport Group – an update on the s106 funded Chinley Station study that Network Rail are currently carrying out and details of a possible funding initiative. The report is anticipated in mid-May.
- 10.) DCC - temporary closure of Footpath 1 in Chinley, Buxworth & Brownside parish from 4 May 2021 to 3 November 2021.
- 11.) DCC – confirmation that the proposed improvement works to the "Railway Steps" on Chinley, Buxworth & Brownside Footpath 22 have been put forward to be carried out by DCC as part of their maintenance schedule and are awaiting approval.
