Items of Correspondence – September 2019

Received: 26 July 2019 – 20 September 2019

- 1.) DALC – voting paper for DALC Executive Committee.
- 2.) Fisher German LLP – requesting that we review and confirm our land ownership in close proximity to their asset. Also advising the basic domestic developments that are generally not permitted within close proximity of a CLH-PS pipeline.
- 3.) Community Rehabilitation Company – detailing the range of unpaid work that they can offer from persons completing Community Payback should it be required.
- 4.) DALC – revised model Financial Regulations 2019 (template) for England and guidance from NALC.
- 5.) Derbyshire War Memorials – advising their website has updated details of war memorials in our parish.
- 6.) High Peak Borough Council – notice that planning permission has been granted for HPK/2019/0252 at Chinley Community Centre subject to conditions.
- 7.) DCC – confirmation that lamp post poppies can be attached to lighting columns or posts in advance of Remembrance Sunday subject to conditions.
- 8.) HPBC Electoral Services – consultation of review of polling districts and polling places in High Peak. No changes recommended within our parish.
- 9.) HPBC - the next Borough Council Parish Forum will take place on Monday 30 September at 2 pm at the Community Centre in Chinley.
- 10.) DCC – details of a survey regarding the Town and Parish Council Liaison Forum.
- 11.) WI – advising that they are planning on holding a 1940's dance on the Saturday of the VE Day 75 weekend and ask whether any funding is available to offset the cost of a band.
- 12.) FOCF – requests for some tree works in Chinley Park, asking whether some path repairs could be carried out on Footpath 22 under the DCC Minor Maintenance Scheme and advising of litter accumulating in the quarry.
- 13.) Sally Curley HPBC – request for Whaley Bridge FC junior team to use our pitch this season due to ongoing work at Toddbrook Reservoir.
- 14.) Kieran Smallbone – requesting permission to use Buxworth Recreation Ground for the Steam Weekend and Buggy Olympics to be held on 28 and 29 September 2019.
- 15.) Local resident – asking whether, given the demand, the Parish Council would look to expand the allotment plots at Buxworth or create a new site due to potentially long waits for allotment plots at both sites?
- 16.) Derbyshire Highways Hub – notification of an emergency temporary road closure on Dolly Lane Buxworth from 18 September 2019 to 9 October 2019 to replace old water main before it bursts. In addition notification of a temporary road closure on Dolly Lane Buxworth from 9 October 2019 to 22 November 2019 to facilitate the renewal of old water pipes.
- 17.) MOP – complaining about the state of the verges in Buxworth and asking for any assistance in rectifying the matter.
- 18.) PKF Littlejohn LLP – notification that they have completed their limited assurance review for the year ended 31 March 2019 and enclose the External Auditor Report and Certificate with no matters arising.
- 19.) DCC – requesting to know whether we would like to continue membership of the Snow Warden scheme.
- 20.) Derbyshire Highways Hub – notification of a temporary road closure on Unnamed Road Chinley from its junction with the B6062 Lower Lane (Leaden Knowle) to its junction with the Peak Forest Tramway from 12 October 2019 to 20 October 2019 to facilitate carriageway resurfacing works.
- 21.) Community Association – request for 8 new fold-up tables for the Community Centre to increase the flexibility of the use of the small meeting room and the tables at a total cost of £631.60 plus VAT from Mogo Direct.
